Before practicing law, Mr. Hillyer worked as a synthetic organic chemist for DuPont Merck Research Laboratories, where he authored several papers on the synthesis of cardiovascular drug candidates. Mr. Hillyer also served as an Adjunct Professor of Chemistry at Wingate University.
